4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist. For breathing difficulties, oxygen may be necessary.

5. Fire-fighting measures

6. Accidental release measures

Methods and materials for containment and cleaning up	Wear appropriate protective equipment and clothing during clean-up. Ensure adequate ventilation. Avoid release to the environment. Prevent entry into waterways, sewer, basements or confined areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Large Spills: Stop the flow of material, if this is without risk. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water. Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

7. Handling and storage

Precautions for safe handling	Ensure adequate ventilation. Keep away from heat, sparks and open flame. Wear personal protective equipment. Avoid breathing mist or vapour. Avoid contact with eyes, skin, and clothing. Do not taste or swallow. Wash thoroughly after handling. When using, do not eat, drink or smoke. Avoid release to the environment. Conditions for safe storage, including any incompatibilities	Store locked up. Store in tightly closed original container. Store in a well-ventilated place. Store out of direct sunlight in dark, dry conditions. @ 15-30°C (59-86°F). Protect from heat and light. Do not allow material to freeze. Store away from incompatible materials (see Section 10 of the SDS). Keep out of the reach of children. Keep away from food, drink and animal feeding stuffs.
